HONOURS AND DISTINCTIONS

Dr. J. A. L. Matheson, Vice-Chancellor, has been elected a Member of the Council of the Institution of Civil Engineers.

Professor D. P. Derham, Dean of the Faculty of Law, has accepted the invitation of the Commonwealth Government to serve as a member of the Australian Universities Commission.

CHAIR OF LAW.

Mr. D. C. Jackson has been appointed to a further Chair of Law in Monash. Before this appointment Professor Jackson held a senior lectureship in the Faculty of Law.

Professor Jackson graduated as Bachelor of Arts (Jurisprudence) with First Class Honours (1953) and Bachelor of Civil Law with First Class Honours (1954) in the University of Oxford and qualified for the degree of Master of Arts in that University in 1957. He has held the following appointments: Bigelow Teaching Fellow, University of Chicago (1954-55), Tutor, St. Edmund Hall, Oxford (1958-63), Assistant to the Director, British Institute of Comparative and International Law (1962-63), Senior Lecturer in Law and Vice-Dean of the Faculty of Law, University of Singapore (1963-64). From 1955-56 Professor Jackson was a Fellow of the Association of the Bar of the City of New York and from 1959-63 he practised at the English Bar. From 1957-59 in fulfilment of the British national service requirement he held a commission in the British Army Intelligence Corps.

Professor Jackson's research interests have been concerned with the United States Federal Loyalty Security Programme, United States' commercial treaties and the

application of English Law to the Commonwealth. His special interests are in the law of Equity, Property, Contract and Tort. Over the years 1957 to 1964 he has contributed articles and notes to Modern Law Review, University of Sydney Law Review, International and Comparative Law Quarterly, Malaya Law Review and Law Quarterly Review.

Professor Jackson is married.

ASSOCIATE PROFESSOR.

Dr. K. W. Rankin of the Department of Philosophy has been promoted to an Associate Professor.

Dr. Rankin, who was awarded the degree of Master of Arts by the University of Edinburgh in 1946 and the degree of Doctor of Philosophy by the same university in 1956, was appointed Senior Lecturer in the Department of Philosophy on 8th March, 1962 and, since Professor Monro's departure on study leave in December, 1964, has been Acting Chairman of the Department of Philosophy.

Before joining the staff of Monash University Dr. Rankin was a Senior Lecturer in the Department of Philosophy at the University of Malaya in Singapore. He has had wide teaching experience in a variety of philosophical fields at the University of Edinburgh, the University of Malaya in Singapore and Monash University and is an experienced administrator, having acted for the Head of the Department of Philosophy at the University of Malaya in Singapore on several occasions.

Dr. Rankin has published a number of articles in Philosophical Quarterly; Mind; The Australasian Journal of Philosophy and The Indian Journal of Philosophy and is the author of Choice and Chance; A Libertarian Analysis which was published by Blackwells in 1962.

STAFF ARRIVALS.

Professor U. G. E. Hammarstrom (Linguistics), Professor T. A. Jones (Music), and Professor P. L. Waller (Law) took up duties on the 1st. June. Notes on these appointments were published in previous issues of the Reporter.

Dr. J. Ignaczak, Senior Lecturer in Mathematics - graduated from the Division of Applied Mathematics at Warsaw University in 1957. In 1960 he was awarded the Diploma of Doctor of Technical Sciences and in 1963 the Diploma of Habilitated Doctor by the Polish Academy of Sciences. From 1961 to 1962 he was a Visiting Research Associate in the Division of Applied Mathematics at Brown University, U.S.A. His main research interests

are related to dynamic problems of theory of elasticity and thermoelasticity and he has published several articles in this field. He at present holds a research appointment in the Department of Mechanics of Continuous Media, Polish Academy of Sciences.

Dr. Ignaczak is married with one child.

Mr. P. F. Thomson - Lecturer in Civil Engineering - graduated B.Met.E. in 1956 and M.Eng.Sc. in 1959 from the University of Melbourne. From 1957-1962 he was a Senior Demonstrator and from 1962-1964 an Assistant Lecturer in Metallurgy at the same University.

He at present holds a G.M.-H. Postgraduate Research Fellowship and is completing a thesis entitled "The Effect of the Stress System in Metal-deforming Processes" for his Ph.D.

COMMUNITY AID ABROAD - (formerly Food for Peace Campaign)

Proposal to form a Monash CAA Group. - The following letter has been received from the Director of CAA, Mr. David Scott :-

"A number of students and staff members at Monash University have expressed interest in the formation of a Community Aid Abroad Group. There are already CAA Groups at the Melbourne and Adelaide Universities.

There are now 67 CAA Groups in Australia assisting specific projects in India and other countries of Asia and Africa. These projects are aimed at increasing food production, creating more employment and extending education and health services at a village or district level.

We hope that a Monash University Group would provide some financial assistance for a particular project but an important function of such a Group would be to promote an understanding of the economic and social needs of developing countries, create an awareness of Australia's responsibilities to assist, and to stimulate interest in questions such as trade and aid, overseas service and the functions of Government and voluntary overseas aid organisations.

Professor Basil Johnson has consented to Chair a meeting to discuss the proposed formation of a Monash CAA Group. This meeting will be held on Friday, July 30th, at 1 p.m. in the Women's Lounge on the First Floor of the Union. (South-west Corner)

All interested students and members of staff are invited to attend."

STATISTICS LIBRARY.

The Faculty of Economics and Politics has recently opened its Statistics Library, Room 159 in the Menzies Building. The library comprises the Faculty's collection of statistical material published by Australian governments and international agencies such as U.N., O.E.E.C., I.L.O.; annual reports and publications of government departments and semi-governmental authorities. It is intended that this library should develop as the University's main collection of social and economic statistics. APPOINTMENTS TO AUSTRALIAN UNIVERSITIES COMMISSION.

The Minister-in-Charge of Commonwealth Activities in Education and Research, Senator Gorton, has announced the re-appointment of the Chairman and four members of the Australian Universities Commission, together with the appointment of two new members.

Senator Gorton said that Sir Leslie Martin, who had given distinguished service as Chairman since the institution of the Commission, would continue as Chairman until 30th June, 1966. In addition, Sir James Vernon, Professor Bayliss, Professor Sunderland and Professor Trendall would continue as members for a further three years. Two former members of the Commission, Sir Kenneth Wills of Adelaide and Mr. Kenneth Myer of Melbourne, had both found, because of the pressure of their other commitments, they would be unable to continue to serve on the Commission. Senator Gorton expressed his thanks and those of the Government to Sir Kenneth and Mr. Myer for their important contribution to the work of the Commission, which demanded a large sacrifice of both time and effort of its part-time members.

Professor D. P. Derham and Mr. R. A. Simpson have been appointed to the Commission for the first time. Professor Derham is Dean of the Faculty of Law at Monash University and has already given the Commonwealth valuable advice on legal problems in Papua/New Guinea; as a member of the Martin Committee on Tertiary Education; and as an assessor to the academic salaries inquiry. Mr. Simpson is a prominent Adelaide businessman, a Director amongst other undertakings of Simpson/Pope Holdings Limited; he has been interested in the problems of higher education for many years and since 1959 has been Chairman of the Finance Committee of the University of Adelaide.

Senator Gorton said that, because of steady growth in the work of the Commission, the Government had recently decided to increase the part-time membership of the Commission from six to eight; this together with the full-time Chairman, Sir Leslie Martin, would make a total of nine members. Amending legislation to permit the proposed increase would be introduced during the coming Budget Session.

MONASH UNIVERSITY STAFF DRAMA GROUP.

With the adoption of a Constitution at a meeting of members on 5th July, the former Monash University Staff Theatre became the Monash University Staff Drama Group. This change was mainly prompted by a desire to avoid the difficulties which might have arisen out of the fact that the old name could be taken as referring to one of two other Monash societies with similar names. Inter alia, the Constitution also stated that "membership of the society, which shall be obtainable by application to the Secretary, shall be open to members of staff, both academic and non-academic, of Monash University, graduates of any university recognised by Monash University, and husbands or wives of members of staff and graduates". Membership is free, and ensures receipt of all circulars sent out concerning the group's activities. The Secretary of the group is Betty Moore ('phone ext. 2140).

On Monday 26th July the group will hold another Intimate Theatre Evening, entitled "Americana Here I Come", at which there will be renditions of American folk-songs, poems, short plays, and humour. CENTRE OF AUSTRALIAN STUDIES.

A postgraduate centre of Australian studies at Monash is at present under active consideration. In April the Faculty of Arts agreed nem. con. to the establishment of such a centre and asked the Professorial Board to establish an inter-faculty committee to work out the details. The Faculty felt that such a Centre was in accordance with the recommendation of its research committee that post-graduate centres in the University should be based on strong specialised interests already developed within various departments. The Professorial Board has appointed a committee comprising representatives of interested departments (Anthropology & Sociology, Economics, Education, English, Geography, History, Law and Politics) to consider the scheme. The Dean of the Faculty of Medicine has also expressed an interest in the use of such a Centre to undertake research in the field of social medicine.

The scheme derives from a conviction that there is an urgent need to step up the volume of research in this field, for example sociological and political studies. The Centre would be designed to attract both outside finance and research students to the whole field of Australian social studies in the University by complementing department programmes with both inter-disciplinary and individual projects. The actual fields of enquiry to be undertaken first have not yet been determined, but it has been suggested that one important field would be regional and community studies (both rural and urban) in which sociologists, political scientists, historians, and economists would work together. Migrant studies is another field suggested, also social aspects of law, crime and education. The severe competition which now exists among Australian universities for research students in Australian studies and the problem of paying for an adequate volume of research makes, it has been suggested, the creation of a special institution of this kind desirable. The undeveloped scope for inter-disciplinary research provides an additional raison d'etre.

As yet no Australian university has such a Centre, but partial analogies abroad are to be found in the Institute of Canadian Studies at Carleton University, Ottawa, in the Institute of Commonwealth Studies, London, in the Commonwealth Studies Centre at Duke University, North Carolina, and elsewhere.

ECONOMICS.

Several members of staff will be travelling overseas shortly, on study leave or for post-graduate study.

Dr. G. G. Pursell leaves in August for a period of study leave at Harvard University, where he will continue previous research on insurance and industrial organization.

Mr. A. I. Clunies Ross leaves later in the year for a period of six months at the University of the Philippines in Manila. He will study the planning and implementation of economic policy under the present Philippine Administration.

Mr. C. G. Peirson leaves in August for the University of California in Berkeley, where he has a temporary teaching position in Business Administration.

Mr. P. C. L. McDonell leaves in August for Oxford University to begin study for a B.Phil. degree in Economics.

MODERN LANGUAGES.

From June 1st to 4th, the Department of Modern Languages co-operated with the Australian Adult Education Association in the organization of a Modern Languages Workshop for tutors of adult classes from all states of Australia. Teachers of eleven different languages participated in a programme of lectures, discussions and demonstrations dealing with the particular problems of adult students, suitable methods for adult language classes and the use of modern aids to language teaching. The members of the workshop were welcomed by the Vice-Chancellor and Professor L. Bodi - the initiator of the project. Lectures and demonstrations were given by Dr. W. Rivers, Mr. H. Clyne, Mr. R. Lamerand, Dr. B. Beaton and Mrs. A. Bonyhady.

On May 13th. Dr. W. Rivers addressed the annual congress of the Modern Language Teachers' Association on "Testing Techniques." On July 7th, under the auspices of the University of Melbourne Extension Committee and the Melbourne Mediaeval Group, Dr. N. Morcovescu delivered an address entitled, "Towards the Reconstruction of the Grail Legend: The Earliest Surviving Texts." A further seminar in the series organised jointly by the French Section and the Melbourne University Department of French was held on the 25th June. Mademoiselle M. Giroux read a paper on "Imagination, poésie, ironie et humour dans les Contes de Fées de Madame d'Aulnoy." At the next seminar, to be held at Monash at 7.45 p.m. on 23rd. July Miss F. Dalton,

research student in the French Section, will read a paper on "Guillevic's Relationship to the World of Objects." On September 17th at Monash, Mr. R. Lamerand will speak on "Approaching the French Language by way of Japanese." These seminars are open to all staff of any Faculty.
